## Deadlines for Open Enrollment

PEEHIP's annual Open Enrollment period began July 1 and ends with the following deadlines. This is the once-per-year opportunity for PEEHIP members to enroll in or change coverage. Outside of Open Enrollment, changes are only permissible due to a qualifying life event. View more information in the [July PEEHIP Advisor](#).

- ◆ **Online: September 10, 2018.** After this time, online Open Enrollment changes will not be accepted and the Open Enrollment link will be closed. **Online enrollment is the preferred option because it is the easiest and most efficient method to enroll in or make changes to your coverage. No other enrollment method provides an enrollment confirmation page in real time giving you instant assurance PEEHIP has received your enrollment request.**
- ◆ **Paper: August 31, 2018.** Any paper forms or faxes postmarked after that date will not be accepted.
- ◆ **Flexible Spending Accounts: September 30, 2018,** for both paper and online Open Enrollment for flex plans.

## Premium Assistance Discounts

If you are an active or retired member who qualifies, based upon your total combined household income and family size, PEEHIP can provide premium assistance discounts up to 50% off of your PEEHIP Hospital Medical premium. The qualification criteria can be found on PEEHIP's Premium Assistance webpage [here](#).

- ◆ If you believe you qualify and would like to apply for this premium assistance, please print and submit the [Premium Assistance Application \(PAA\)](#) from the website listed above, along with your current year **Federal Income Tax Return Transcript** as shown under "Step 2" on the PAA form.
- ◆ If you are approved, PEEHIP will mail you an approval letter showing your discount effective date as well as the discount expiration date. The premium discount does not renew each plan year. If you are currently receiving a premium assistance discount, you must reapply now during PEEHIP's Open Enrollment in order to potentially continue a premium discount into the new plan year beginning October 1, 2018.
