New! Expanded Flex Debit Card

- ◆ PEEHIP members enrolled in the Health Flexible Spending Account (FSA) are now able to swipe their FSA debit card for qualified medical, prescription drug, dental, and vision expenses or copays at the time of service or purchase. Members will no longer be required to pay out-of-pocket first for medical expenses and wait for a reimbursement from their Health FSA.
 - ◇ Each member enrolled will receive a debit card from HealthEquity to access their funds.
 - ◇ If you already have a HealthEquity Visa debit card, the previous limitation of pharmacy-only use was removed October 1.
 - ◇ For validation purposes, please retain copies of any invoices, receipts, and other documents you receive in connection with your FSA card transactions.
