1. Due to instructional limitations and a loss of student engagement that has been created by lack of face to face instruction, students at all grade levels will be afforded the opportunity to receive additional academic support as needed based on diagnostic assessments administered during the first two weeks of school and based on the ongoing formative assessments provided by teachers.

2. Small group tutoring will be based on the ALSDE critical standards review and reteaching. The after school tutoring sessions will be designed based on assessment data and instructors will utilize learning platforms and resources that can be individualized to meet the needs of the learners. Students with unique needs will receive targeted support based on individual plans for instruction.

3. Parents and students with language barriers will receive remediation in their native language or with communication devices that enable active participation by the learner.

4. Evidence based learning activities will be provided in all schools, after school programs and during remote learning sessions.

5. All classrooms, whether remote or face to face, will be taught by certified teachers unless excessive absences by teachers arise due to COVID. To provide continuity and structure for classroom instruction in the schools, full time substitutes will be employed and trained by the district to continue the learning plans established by the teacher to avoid lost instruction time.

Gadsden City School System will provide after school tutoring beginning in Sept. 2020 in order to address on-going academic weaknesses as evidenced by periodic benchmark assessments and ongoing formative assessments.

1. After school tutoring for K3 students will be intentionally planned to provide ongoing reading intervention and an evidence based, dyslexic specified program to address student needs in each of the δ components of reading to align with ALA requirements.

2. After school tutoring will take place after school and students will be grouped according to skill deficiency identified through formation assessments.

3. After school tutors will be certified teachers contracted each week to provide intensive, small group instruction based on intervention needs in groups of 5-10 students.

## How will the LEA plan for implementation and measure impact for effectiveness for purchases identified?

Students will be evaluated at least 3 times per year... beginning, middle and end of the year using Star Renaissance and math assessment, Dibels Amplify, and/or USA Test Prep diagnostic assessment.

All programs and practices used in the district will be evidence based on student data and monthly collaborative team meetings involving teachers, counselors, admin and other stakeholders as needed to analyze the assessment data and make adjustments throughout the year for ongoing process monitoring.

Services will begin as early as September of 2020 and go through September 2022.
