I. EL Students Served

Follow up information from the work session was given to the board members regarding the number of EL students that are being served at each school site.

II. Diploma Options

Mr. Joel Gulledge, GCHS Principal, presented the board with a narrative of the three diploma types at Gadsden City High School that a student may earn.

- *Alabama High School Diploma
- *Advanced Diploma
- *Honors Diploma

Mr. Gulledge explained the reason for having the Advanced Diploma type is to meet those students who would fall in the middle between a Standard and an Honors Diploma. Some students are on a higher level than the standard classes but are not ready for the rigor of AP classes. Those are the students who will fall under the Advanced Diploma type. These students can still take AP classes if they so choose, but are only required to take the Advanced Classes. Teachers will be able to solely focus on either Standard, Advanced, or Honors classes, which will allow them to reach students at their proper academic level.

The Advanced Diploma also falls in line with the new Titan Signature Academies.

^{*}The career path would be for those students on the standard diploma.

^{*}The college path would be those students on the Advanced diploma.

^{*}The honor path would be those students on the Honors diploma.
