Mrs. Marcia Farabee, Director of Curriculum and Instruction, presented the Summer School plan for Elementary and Secondary failures. The summer school for elementary students will be held in two locations; Striplin and Floyd Elementary Schools. The times will be from 7:45 a.m. to 3:00 p.m. The ACAP scores are scheduled to be released on May 17th, which will be an indicator for students that will require remediation. The secondary remediation classes will be held at GCHS. Any student that has failed two courses will have the opportunity to attend summer school. The cost of summer school is \$200 per student for any student with excessive absences. Currently, there are 402 students eligible for summer school with an expected number of 600 students.
