A. Call to Order, Opening Prayer, Pledge of Allegiance

Chairman Allen Millican called the meeting to order. Mrs. Rita Smith led with prayer followed by the pledge of allegiance.

B. Recognition of Visitors/Guests

1. Elementary 3rd Grade Teachers and Reading Coaches

Superintendent Keith Blackwell recognized the system's 3rd grade teachers, Reading Coaches and EL Teachers, for their dedication, instruction and service to third grade students of Gadsden City Schools. The system performed above the state average on the ACAP test, which is the Alabama Comprehensive Assessment Program that evaluates students' achievement in the Alabama Course of Study Standards, and will determine if a student may be promoted to the next grade level. Gadsden City Schools had 92% of its third-graders pass the ACAP.

2. Naomi Taylor - 9th grader GCHS Student - Alabama Million Girls Moonshot Cohort

Naomi Taylor, a 9th grade student at Gadsden City High School, was selected to participate in the Alabama Million Girls Moonshot. The Million Girls Moonshot is a group of youth who impact STEM experiences beyond the classroom. These young leaders are currently working in their communities to break down stereotypes and spark their peers' curiosity in STEM. The girls are learning to build a better future for young girls in the area of STEM.

3. Naomi Crowder - 11th Grade student GCHS - Alabama Million Girls Moonshot

Naomi Crowder is a current 11th grade student at Gadsden City High School who was also selected for the Alabama Million Girls Moonshot.

4. Nyla Franklin - GCHS State Champion Track

Nyla Franklin, an 8th grade student at Gadsden Middle School, competed and won the AHSAA state championship for 6A Track and Field in the High Jump. Superintendent Blackwell recognized her for this great accomplishment and for representing Gadsden City High School.
